Leave of Absence to Temporary Employee.

AUDIT OFFICE, OTTAWA, May 12, 1898.

SIR,-I beg to inform you that I have received an Order in Council of the 3rd instant, directing that Mr. F. G. Gray, who has been employed as a temporary clerk in the inside service of the Post Office Department since October 17, 1892, at a salary of \$400 a year, be granted leave of absence from July 1 to September 1, 1898, at which latter date his resignation as such clerk shall be accepted by the department.

I call your attention to this matter because, in my opinion, it is not legal to grant the leave of absence contemplated by the Order in Council referred to.

Under section 47 of the Civil Service Act, as amended by 58-59 Victoria, chapter 15, the Governor in Council may authorize the employment of such number of temporary clerks, &c., as is shown to be necessary on account of temporary pressure of work or other cause in any department, and that the clerks so appointed may be continued in such employment so long as the pressure of work remains, but no temporary employment shall give any person so employed any claim to further temporary employment.

If, then, the department is in a position to dispense with the services of Mr. Gray on July 1, it has no authority to pay him for a period beyond that date, as the pressure of work which necessitated his employment must have ceased to exist, or has been met

by another appointment.
