Subamendment of Mr. Fansher; seasonal tariff on fruits and vegetables; native labourers in competition with Canadians; increase in the British preference; protection of the textile industry in Quebec, 2085; cotton and cotton cloth and yarn mills in Canada; revision of the Canadian cotton tariff schedule; reduction in number of cotton mill workers, 2086; hours of labour in Canadian and United States cotton mills; wages paid in Lancashire mills and in Canadian cotton mills; imports of textiles into Canada; cotton industry in Great Britain suffering from competition from the East; formation of the Lancashire Cotton Corporation; overproduction of cottons in the United States; development of cotton manufacture in the Southern States; Canadian tariff rates on cottons from the United States; failure to protect Canadian cotton mills from competition of
