SUPPLY OF BAIT TO LOBSTER FISHERMEN, DIGBY, N.S.

Hon. R. W. Mayhew (Minister of Fisheries): Yesterday the hon. member for Rosetown-Biggar (Mr. Coldwell) asked a question about seining for herring in Digby basin. I should like now to answer the question.

The department has received two telegrams with reference to winter seining in Annapolis basin. The department's information is that of six weirs licensed in the basin, one only operated this winter, and it has operated only partly. Three seine boats had been operating up to recently in the basin, but ceased operations at the end of last week.
