LOANS FOR RESIDENCE CONSTRUCTION, RYERSON INSTITUTE

Question No. 1,171-Mr. Scott (Danforth):

- 1. Has the government received representations from students and/or officials of the Ryerson Polytechnical Institute in Toronto, with respect to making that institute eligible for N.H.A. loans for the construction of student residence buildings?
- 2. If so, what was the nature of the representations, and what was the nature of the government's response?

Hon. J. R. Nicholson (Minister of Labour): 1. Yes.

2. In the representations made on behalf of extending the facilities of the N.H.A. to [Mr. Pepin.]

cover the financing of residence for students attending Ryerson Polytechnical Institute, the following points were made:

(a) it is becoming increasingly difficult to find suitable accommodation for students in the immediate area;

- (b) it is expected that the student body will more than double within the next five years and;
- (c) the courses offered by Ryerson play an important role in preparing young people to meet their responsibilities in our technical society and, therefore, similar financing should be available as in the case of universities.

The reply to these representations was that the financing could not be offered under present legislation, but that careful consideration would be given to the recommendations that the act be amended.

POTATO WAREHOUSE STORAGE ASSISTANCE ACT

Question No. 1,175-Mr. Jorgenson:

- 1. Has the potato warehouse storage assistance act been discontinued and, if so, when?
- 2. Was the program reinstated and, if so (a) on what date (b) how many loans have been granted since its reinstatement (c) to whom were these loans made?
- Hon. J. J. Greene (Minister of Agriculture): 1 and 2. The program of assistance in the construction of potato warehouses was discontinued in July, 1962 and has not been reinstated. Commitments made prior to that date have been honoured.
