YELLOWKNIFE, N.W.T.—PROHIBITORY REGULATIONS FOR AKAITCHO HALL

Question No. 1,588—Mr. Orlikow:

Do the regulations applicable to students residing at Akaitcho Hall, Yellowknife (a) prohibit students from visiting homes in Yellowknife without special permission from the Head Supervisor (b) prohibit students from riding in cars or taxis without permission from the Supervisors on penalty of dismissal from Akaitcho Hall (c) prohibit students who own cars from driving them while in Residence and require keys to such cars to be left with the Residence Superintendent (d) make the Old Town out of bounds to Residence students except with special permission from the Head Supervisor and, if so, what are the reasons for this prohibition (e) require students to attend church every Sunday morning and prohibit Sunday leave to students who have not attended church (f) require students invited to the homes of friends in Yellowknife to inform the Supervisor before accepting the invitation (g) require students' guests to Akaitcho Hall to sign the Guest Book and report to the Supervisor on duty?

YELLOWKNIFE, N.W.T.—DATE OF PROMULGATION OF AKAITCHO HALL REGULATIONS

Question No. 1,589—Mr. Orlikow:

1. When were the regulations governing students living at Akaitcho Hall, Yellowknife promulgated and by whom?

2. Have the regulations for students at Akaitcho Hall been changed since first promulgated?

3. Have the regulations at Akaitcho Hall been approved by any officials of the Department of Indian Affairs and Northern Development beside the Resident Superintendent?

4. Were the regulations brought to the attention of any officials of the Department by the Superintendent of Akaitcho Hall and, if so, did they offer suggestions for changes, amendments, modifications, etc. and, if so, when and what suggestions were made by the Department?

5. Is each student at Akaitcho Hall required to sign a statement that he or she accepts these regulations?

6. Does the Department approve of these detailed regulations for students residing at Akaitcho Hall?

7. Do any of the other residences operated by the Department of Indian Affairs and Northern Development have similar regulations governing the living conditions of the residents?

Hon. Jean Chrétien (Minister of Indian Affairs and Northern Development): 1. The first regulations were outlined in 1958 by the Residence Superintendent.

2. These were revised in 1962 and again in 1964 and have been reviewed every year since 1964. The present regulations were promulgated in 1969.

3. Yes, by the Principal of Sir John Franklyn School.

4. Yes. No suggestions for amendments to the present regulations have been made by field officers of the Department.

7. Yes. The regulations at the other large residences operated by the Department at Fort Churchill, Manitoba and Whitehorse, Y.T. are appropriate to the situations there.
