RECOGNITION OF PEOPLE'S REPUBLIC OF CHINA—DIS-CUSSION RESPECTING NUCLEAR TESTS

Mr. Georges Valade (Sainte-Marie): Mr. Speaker, I have a question for the Prime Minister.

Since the recognition of Communist China by the present government, does the Prime Minister know that this morning an atomic bomb was exploded on the Chinese communist mainland, and did the Canadian government, during the talks which resulted in this official recognition, demand that China stop atomic tests as a prerequisite to recognition by Canada?

Right Hon. P. E. Trudeau (Prime Minister): The answer to both questions is no, Mr. Speaker.

Mr. Valade: Mr. Speaker, I want to ask a supplementary question.

I should like to ask the Prime Minister whether, during his visit to Russia, he will take this opportunity to discuss the suspension of atomic tests in Communist Russia and in Communist China as well.

Mr. Trudeau: Mr. Speaker, there is no doubt that the discussions will cover the problem of disarmament in general and nuclear disarmament in particular. It is also possible that we will talk about international relations in general and China in particular.
