RAPESEED—TYPE OF CHARGES LAID BY WHEAT BOARD AGAINST CERTAIN FARMERS FOR OVERDELIVERY

CONSULTATION WITH PROVINCES ON NEEDS—INTRODUCTION OF LEGISLATION

Mr. Basford: The municipalities were represented at most, if not all, of the consultations with the provinces.
