increased the amount of the benefit to the users of these and other pasture lands in terms of deep water wells, dams for cattle and so on.

**Mr. Knight:** Mr. Speaker, in view of the fact that the increase of expenditures in this area does not necessarily mean an expansion of community services to producers in terms of grazing land, can the minister outline any program under PFRA to increase community pastures in the west where those possibilities arise?

**Mr. Jamieson:** Mr. Speaker, in a very general way I might say that I have had consultations with one of the ministers of the government of Saskatchewan, and my officials have also discussed the same subject with officials of the government of Saskatchewan with a view to getting certain changes made in the ARDA agreement, but at the moment this has not been completed.

### HIGH WATER LEVEL IN LAKE ERIE—REQUEST THAT ARDA FUNDS BE PROVIDED IN CERTAIN AREAS SUFFERING EROSION

**Mr. William Knowles (Norfolk-Haldimand):** Mr. Speaker, my question is directed to the Minister of the Environment. In view of the fact that \$2.7 million remains available for flood control at the western end of Lake Erie under the ARDA program, will he indicate that the same assistance can be provided for other areas along Lake Erie which are suffering from erosion damage?

**Hon.** Jack Davis (Minister of the Environment): Mr. Speaker, this money was made available under the ARDA agreement which is for the protection of agricultural land and was made on the advice of the Ontario government. The federal government agreed to share 50-50 in that plan.

**Mr. Knowles (Norfolk-Haldimand):** Mr. Speaker, in view of the fact the minister and some of his colleagues are meeting with their counterparts from the provincial government of Ontario in the near future, will he put forward the suggestion that the federal government would be willing to use the ARDA program to compensate farmers for farmlands lost through erosion?

**Mr. Davis:** Yes, Mr. Speaker. That matter was discussed with ministers from Ontario who were here in Ottawa this morning, and that compensation was agreed upon.
