On motion of Mr. Borden, the Order No. 35 on Public Bills and Orders was called.

The said Order was called :---

Mr. Macdonald, That Bill No. 95, An Act to amend Chapter 26 of the Acts 9-10 Edward VII, entitled, "An Act to provide for the adjudication of small claims arising in respect of the operation of the Government Railways," be now read the second time; which was agreed to.

The said Bill was accordingly read the second time, considered in Committee of the Whole, reported with amendments, considered as amended, read the third time. (Title changed to "An Act to amend the Government Railways Small Claims Act), and passed.

The Bill No. 248, An Act to amend the Post Office Act, was read the second time, considered in Committee of the Whole, reported without amendment, read the third time and passed.

## THURSDAY, June 5, 1913

Mr. Crothers laid on the Table of the House, by command of His Excellency the Administrator,-Report of Royal Commission on Industrial Training and Technical Education, Parts I, II, III and IV.

Mr. Hazen presented,—Return to an Order of the House of the 26th May, 1913, for a copy of all letters, reports, complaints and other communications and documents which passed between General McKenzie and the Minister of Militia or his Department, previous to, and which led up to the resignation of General McKenzie; and also a copy of said resignation, and the reply of the Minister thereto, and of any and all communications had with the War Office thereto, and of all other papers and documents in connection therewith.

Mr. Hazen presented,—Return to an Order of the House of the 29th January, 1913, for a copy of all letters, petitions, telegrams, complaints, evidence, reports and other papers and documents in the possession of the Department of Marine and Fisheries, or any Department of the Government relating to the dismissal of Levi Munroe, Harbour Master at White Head, N.S., and if there was an investigation, the names of all witnesses examined, a copy of the evidence, and a detailed statement of the expenses of such investigation.

The Bill No. 195, An Act to amend the Railway Belt Water Act, was considered in Committee of the Whole, reported with amendments, considered as amended, read the third time and passed.

The Bill No. 243, An Act to amend the Judges Act, was considered in Committee of the Whole (together with the Resolution adopted in Committee this day referred) reported without amendment, read the third time and passed.

The Bill No. 199, An Act to amend the Inspection and Sale Act, was again considered in Committee of the Whole, reported without amendment, read the third time and passed.

The Bill No. 240, An Act to amend the Public Archives Act was read the second time, considered in Committee of the Whole, reported without amendment, read the third time and passed.

The House then adjourned at 1.28 o'clock, a.m., until 11 o'clock, a.m., this day.
