SCOTLAND YARD DENIES CRIPPEN HAS CONFESSED

Altho Daily Chronicle Prints a Circumstantial Statement—Defense Counsel Confident.

LONDON, Aug. 4.—Superintendent Frost of Scotland Yard again to-day gave his personal assurance that not a single word had been received from Inspector Dew that Dr. Crippen had confessed. He added that if a confession had been made he certainly would have been informed.

Solicitor Newton, who has been retained to defend Dr. Crippen, made his first move to-day when he filed a formal application, asking the authorities to permit an independent physician to examine the bits of human flesh found in the Crippen cellar. Newton will contend that they cannot be identified as having belonged to the body of Belle Elmore.

"It seems to me, upon the evidence already available, that the case against Dr. Crippen is not one to discourage me in the smallest degree. So far as I can see, there is no kind of evidence that a murder has actually been committed," he said to-day.

The confession attributed to Dr. Crippen, and carried by The London Chronicle, is as follows: "It is quite true that I did kill my wife, but it was a mistake that I made in trying to hide it. We should not have done this. I meant it for the best, tho. I will say nothing of my wife's death until I return to England. Then I shall prove that she killed me. I was not a murderer. I make this confession in order to free Miss Leneve from suspicion. She, poor girl, knew absolutely nothing of my wife's disappearance except what I have told her."

Relatives have received the following cable from Miss Leneve: "I have just received your letter and am glad to hear you are returning home—Ethel."

The question whether Crippen and his companion have been married has been revived because of its bearing on the status of the woman as a possible witness against Crippen. To-day Superintendent Frost said that a exhaustive official examination had failed to produce any evidence of such a marriage.

The police now have a theory that Mrs. Crippen died while undergoing an illegal operation. An instrument said to have been used in the fatal operation will be produced at the coroner's inquest, which was adjourned until Aug. 15. This instrument was found at the Crippen home, 28 Hildrop-crescent, North London, hidden under the floor of the coal cellar, where the dismembered and dissected remains of Mrs. Crippen were also concealed.

The police now assume that if Mrs. Crippen died, her husband cut up her body in a way only one who has studied anatomy and performed autopsies could do, hid the flesh in one place, and possibly burned the bones and trace of the bones having been found.

Crippen's object in this disposing of his wife's corpse, Scotland Yard authorities reason, was to destroy evidence of an illegal operation.

deposit their savings in the Farmers' Bank and that they had certain rumors, he had become alarmed and had simply given his friends a warning. Coulter had also persuaded some of his friends to deposit in the bank so he helped spread the alarm. They felt that having got the men to deposit with them that they would be blamed for anything happened. McGill had heard that the stock was away down around \$11 per share. The par value is \$100.

He also heard about an injunction that had been filed in Syracuse, N.Y., against the bank for \$150,000. Added to information that alleged that some of the branches were not doing well, McGill thought the institution was in dangerous shape.

McGill had decided that the depositors would blame him rightly if, having heard those things, he did not put them in a position to protect themselves.
