### A SMALL MARKET BUT SALES BRISK

**Good Demand for Oats at High Prices—Supply of Butter Small.**

#### LOCAL MARKET.

LONDON, Tuesday, April 21.

The market, though small, was a fairly brisk one for this day of the week. Sales were brisk in every line, and prices held firm, excepting for hay, which was about 50c per ton lower than last week's quotations.

Grain—There were fully 20 loads of oats offered, and there was a good demand at higher prices, the sales ranging from \$1.50 to \$1.57 per cwt.; mostly at \$1.52 to \$1.55 per cwt.

Hay and Straw—There was fairly good demand for hay on the stand. Sales were slow at first, but all the loads had been disposed of by 11:30 o'clock. Prices ranged from \$12 to \$13.50 per cwt. Nearly all sold at \$13 per ton.

Butter and Eggs—The supply of butter was very small, at 28c to 29c per pound for rolls in basket lots, and 28c for crocks. Eggs were not plentiful at 15c and 16c per dozen and basket lots.

Vegetables and Roots—Potatoes were scarce and a little firmer at 55c per bag wholesale, and \$1 and \$1.05 retail. Rhubarb, 90c per dozen, radishes, lettuce and green onions, 35c to 40c per dozen. Onions higher in price at \$1 per bushel.

Very little poultry offered. There was no change in prices.

Dressed Hogs—Sales were fairly brisk at \$3.50 and \$3.75 per cwt.

Butchers' Meat—The supply was small, and prices firm, especially for beef, which sold all the way from \$7 to \$9 per cwt., the latter price being for choice beef or steer beef. Spring lambs sold at \$5.50 to \$7 each. Yearlings, 12c per pound for the carcass. Veal sold mostly at \$7 per cwt.

Maple Syrup—Sales slow at 90c to \$1 per gallon.

Apples—In fair demand at \$1.50 to \$2.25 per barrel, or 50c to 80c per bag.

### PTÉ. MOIR MUST BE TAKEN

Charles W. Robinson, a farmer, Moir went to the back door and asked for something to eat. Mr. Robinson's daughter asked him in, but he refused. He offered to pay for what he got, but his money was refused. Moir then went on his way, and no more was seen of him.

He took to the railway tracks and went in the direction of St. Marys.

#### Not a Sign.

Since that time this neighborhood had been thoroughly scoured. Not a sign has been seen of the desperate soldier, and no person has reported as having seen him.

This clue was not discovered until late yesterday, more than twenty-four hours after Moir had passed. Detectives Nickle and Eggleton were in this neighborhood on Sunday afternoon on a handcar, and must have been but an hour or so behind Moir. He did not touch St. Marys, but avoided the town.

#### In Stone Quarries.

Whether he rested all day Sunday among the many stone quarries in this neighborhood is not known, but it is quite probable.

Last night the London posse took up the trail near Stratford. At 10 o'clock they were working about six miles south and west of Stratford.

#### Many Rumors.

"There are many rumors afloat here this morning," said The Advertiser's correspondent in Stratford, "but so far nothing tangible has been learned."

"The officers are working out of here, about six miles, in the district where Moir is supposed to be."

"There is considerable excitement being manifested, and the whole countryside is on the lookout. If Moir moves at all, it should be known here within a short time."

At St. Marys no definite trace of Moir has been seen.

#### MOIR AT ST. MARYS.

Was Seen About a Mile and a Half From the Town.

"Moir was about a mile and a half south of here on Sunday morning," said The Advertiser's correspondent in St. Marys. "This is the most definite piece of information we have received as yet. There are many rumors afloat, and to believe them Moir has been seen in many places, but there is nothing of a definite nature. He may be hiding in the neighborhood, but some of the unused quarries here, for that is not known. So far as I can learn there has not been a definite clue of Moir since Sunday morning, just 48 hours ago."

#### All on Watch.

Every town in the vicinity of Stratford has been on the watch for Moir, and it is expected that he will come within sight of some of the villages very shortly.

Some are inclined to believe that Moir has committed suicide now that he has realized that his capture is but a matter of very short time.

It is hardly possible they argue that this man could travel 48 hours through the country without food unless he had been seen somewhere, and his presence reported.

#### Working Quietly.

The police are working quietly and doggedly.

They are pursuing every clue, and following every suggestion in their desire to get their man.

They figure that he is bound to betray himself and that he is bound to relax his vigilance before long.

This will be their opportunity. Chief Williams has not heard this morning what has been done, but he declared that his men are working out from Stratford. They had not reported to him since leaving last night.

#### At Thorndale.

It has been discovered where Moir slept in Thorndale. He evidently entered the village in the night, and went to the barn belonging to Mr. J. W. Evans, living in the north end of the village. There Moir slept in one of the horse stalls.

Mr. Evans said that he had gone to the barn early in the evening, and at 6:30 in the morning. There was no person in the barn in the evening, and in the morning he found the stall had been occupied.

#### Man in a Barn.

The detectives also had a thrill near Kelly's Siding, where a man was discovered in a barn. They thought they had their man, but found no more preparations for his capture.

All rushed into the barn, but found no Moir, but a tramp from London. He stated he had been on a spree and was sobering off. He was allowed to go.

#### MURDERER AT GUELPH.

Was Well Known There, and There Are Stories of Him.

Moir was well known in Guelph, where he resided for a couple of years before coming from that city to London.

While there his reputation was none too savory, and he was known to be rather handy with a gun.

Moir had to "jump the town" for a little bit of gun-play, and there is still a warrant out for his arrest on this charge.

One added feature to the information from Guelph is the fact that he was subject to fits, and that he was for some time confined in a hospital suffering from the effects of the attack.

Whether it was an epileptic fit or not is not known.

If it is such, the defense of Moir will probably be insanity in case he is tried for murder.

#### A Bit of History.

The Guelph Herald says: Pte. Moir, the man who, at Wolseley Barracks, London, on Friday, shot and killed Color-Sergeant Lloyd, had some local fame as an ever-ready hand of firearms, and some of his escapades committed in this city a few years ago engaged the attention of the local authorities.

Forty Perish in a Collision

Melbourne, Australia, April 20.

Two trains from Ballarat and Bendigo respectively collided late last night at Braybrook Junction, about eight miles from Melbourne, 41 persons being killed and 60 injured. The Bendigo train, with two heavy engines, crashed into the rear of the Ballarat train. Five cars of the latter train were wrecked. The wreckage took fire and was almost completely consumed.

### Churchill Is With Redmond

As Price of the Irish Votes

Hopes To See Settlement of the Irish Question a la South Africa.

Manchester, April 20.—Winston Spencer Churchill, who is seeking re-election at his recent appointment to the cabinet, made a speech here tonight, which has been awaited by the followers of John Redmond before they undertook to counsel the Nationalists as to how they should vote.

Churchill announced that he had the concurrence of Premier Asquith in saying that at the close of the present Parliament the Liberal party would claim full authority and a free hand to deal with the problem of Irish self-government without being restricted by mere measures of expediency like the abandoned Irish councils bill.

Mr. Churchill said that his recent vote in support of John Redmond's home rule resolution in the House of Commons was no mere perfunctory proceeding.

"It constituted on my part," he said, "a distinct acceptance of an advanced position in the Irish question. My opinion ripened during the two last years I frankly admit. I have become convinced that a national settlement of the Irish question on broad and generous lines is indispensable to a harmonious conception of Liberalism, and I have a great object lesson in my own experience in the matter of South Africa. There they got a risk far greater. I hope some day for a settlement in a similar spirit in Ireland."

Late tonight Mr. Redmond's decision was still awaited. Although Mr. Churchill distinctly stated that the Irish solution must wait until the next general election, the tenor of his speech seems to bear out the rumor that Mr. Redmond delivered a virtual ultimatum as the price of the Irish vote in Manchester.

### SOUTH OXFORD

LIBS NOMINATE

Mr. Thomas Mayberry Chosen

Candidate for the Provincial Legislature

Former Postmaster-General and Minister of Militia Dead at Montreal.

Northwich, April 20.—No fewer than ten names were placed in nomination at the South Oxford Liberal convention here this afternoon, but on the second ballot Mr. Thomas R. Mayberry, of Ingersoll, received a majority of the votes. Before the ballot was taken all retired excepting Messrs. Charles W. Carroll, of North Oxford, Richard Seldon, of North Oxford, and Mayberry. Notwithstanding the number of aspirants, all of whom spoke, there was no dissension in the party, but the choice was quite unanimous. The unusual number of candidates showed that the chances of winning the riding are mentioned.

The other names mentioned were those of Alexander Reese, Ingersoll; R. Hawkins, Erin; Dr. Mackay, Ingersoll; M. T. Buchanan, Ingersoll; Valentine Ficht, East Oxford; Dr. J. M. Rogers, Ingersoll, and William Holmes, Otterville. Over two hundred delegates were present, and so interested are the people of the riding in the political outcome that the town hall was crowded to the doors. The principal speech of the day was delivered by Hon. A. G. MacKay, who made a number of references showing how many members lost their promised independence when in the House. This portion of the leader's speech was most attentively listened to because of the interest of independence on the part of Mr. Donald Sutherland, the present member. Mr. MacKay took the attempts at automatic rule of the present Government, his description of Mr. Speaker Crawford's famous ruling supporting this contention. Then Mr. MacKay turned his attention to the Whitney redistribution bill, and as he showed up the inconsistencies and gerrymandering of the administration he was applauded time and again. On the whole, Mr. MacKay's speech today was a logical, clear-cut and stirring effort, and one that will hardly be forgotten by the large delegation who heard him.

What has Donald Sutherland, our present member, done? Was the query put by nearly every local speaker, and they added that Mr. Sutherland admitted at his recent convention that he had done nothing.

Speaker after speaker severely criticized Mr. Sutherland because he was absent from the Legislature when the bill guaranteeing the Canadian Northern bonds went through. BROUGHDALE BUSINESS BROUGHDALE PEOPLE

IS ON THE BOOM WANT SITE FOR SCHOOL

Fine New Land Survey Has Just Been Opened Up.

That Broughdale, like East London, is a coming business section, is very evident.

One of the most picturesque land surveys ever offered on the London market is now on sale there.

St. Joseph's Park is a beautiful piece of ground, made up of about one hundred city lots.

The park is as high and level as a bowling green. Along the north and east the River Thames forms the most beautiful boundary possible.

The shaded millrace bounds the south, and Richmond street the west. The proposed streets are wide and well graded.

On the river bank, along the eastern border, will be St. Joseph's avenue, a shaded street overlooking the river. It is similar to The Ridgeway in South London.

Wm. Bernard & Co., who are conducting the sale, have a large gang of men at work improving the survey.

Sixty-six foot streets are being graded and gravelled. Trees are being planted along the boulevards.

At the rear of each lot is a 12-foot lane, a convenience which is badly needed in London.

St. Luke's (Anglican) Church is on the survey, and it is expected that the county will shortly build a school there. The street railway passes the property.

There are rumors that the park is flooded by the Thames in the spring, said Mr. Bernard. "This is untrue. I have owned the property for 24 years, and during that time it has never been flooded."

Mr. Bernard owns a vein of gravel along the river, and he offers to give all purchasers gravel free for use in the park.

Yesterday, the first day of the sale, nearly 25 lots were sold.

### SUDDEN DEATH

OF SIR A. CARON

Former Postmaster-General and Minister of Militia Dead at Montreal.

Montreal, April 20.—Another familiar figure in Canadian political life has been removed by the death of Sir Adolphe Caron, former Minister of Militia and Postmaster-General of Canada, which occurred this afternoon at the Royal Victoria Hospital in this city. Sir Adolphe had been suffering for some time with a serious throat trouble, and on Saturday he was stricken with pneumonia. His condition became alarmingly worse until this afternoon, it was deemed advisable to remove him from his quarters at the Windsor Hotel to the hospital. A few hours after his admission he passed away.

The remains were placed on the Quebec express tonight for conveyance to Quebec, his old home, where interment will take place.

Sir Adolphe Caron was born to politics and grew up in an atmosphere of public affairs. He was the son of Hon. R. E. Caron, a Judge and at his death, Lieut.-Governor of Quebec. Born at Quebec in 1843, the younger Caron went in due course to the Seminary and afterwards to McGill, whence he graduated in law in 1865.

In 1874 he came to Montreal, and entered the Commons as member for Quebec county in the Conservative interest. He sat in the House continuously until the general election of 1900. From 1880 until 1892 he was minister of militia, and from 1892 until he left office with Sir Mackenzie Bowell on April 27, 1896, Sir Adolphe was postmaster-general. He was knighted for his services in organizing the expedition of 1885 against Riel. Sir Adolphe was not notable as a public speaker. His strength consisted in his organization work and to that end much money was required. This necessity brought his name somewhat prominently before the people of Canada in the closing days of Sir John Macdonald's life.

Sir Adolphe was one of the most picturesque members of the Commons. He wore a monocle, spoke English with a drawl that would not have come amiss at Westminster, and dressed better than any other man in the House. So far in these directions did the minister go that sometimes he was spoken of in his native province as an Anglo-maniac. He was a great personal friend of Sir John Macdonald and it was believed that the way in which he stood up against the Nationalist movement in Quebec did much to strengthen his hold over Sir John. Since his retirement from public life he has been identified with
