Of this route, there would be 46 miles on land and 22 on water. For water transit, fast and handsome steamers, capable of making twenty miles an hour, were to be put on. In addition to these, there were to be transit vessels, capable of carrying forty railway cars, thus doing away with the necessity of transshipment.

The Laws Delays.
The following list of cases was docketed for the Supreme Court, yesterday: King Chung vs. Mason, appeal from Mr. Justice Crease; King & Casey vs. Victoria Lumber Company vs. the Queen, appeal from Judge H. Harrison of the Court of Revision; Foley vs. Webster, appeal from Mr. Justice McCredie; Harper vs. Cameron, appeal from Mr. Justice Crease. When the court opened, his Lordship the Chief Justice, Mr. Justice Crease, Mr. Justice Walker, and Mr. Justice Drake, were on the Bench, facing an array of legal talent consisting of no less than nine brilliant luminaries of the law.

The items making up the total amount to be expended on the whole line of rail and ferry service, were:

Sixty-six and one-half miles, at \$21,200
Yankee branch, 243,000
Main line and branches, 1,265,000
Cape Pass, 125,000
The total amount of cash to be expended was \$1,703,000. Mr. De Cosmos, with reference to the second of these items, stated that the promoters had no intention whatever to give up their proposed Blaine branch.

It was also intended, and this was a most important scheme in connection with the work that a branch line of rail should be run from Victoria to Esquimalt, to connect at the latter place with spacious wharves, docks and machine shops. Applied already made for the bonding of property at Esquimalt, and, no doubt, ocean vessels would gladly take advantage of the
