THE BRIBERS TO BE TRIED

THEIR DEMITRRER OFERRULED BY THE FULL COURT,

Judge O'Connor Holds Bribery a Non-Offence-The Bribers Say They Will Appeal to the Supremo

Court.

The full court of queen's bench gave indoment vesterday in the demurrer raised by the bribery conspirators, declaring that Bunting, Meek, Wilkinson and Lirkland must stand their trial. Last fall they were indicted before the assizes on a charge of conspiracy to bribe members of the legislature. Just as their trial was to come on at the assizes the demurrer was made, on the ground that the offence with which they were charged was not one indictable under the common law, and that the charges were not sufficiently specific in their char-

acter. The merits of the demurrer were argued at great length by counsel on both sides some time ago, and since then their lordships have considered the whole subject with a thoroughness which was mani-fest in the length of the judgments and the exhaustive manner in which legal history had been searched for precedents, Meek and Wilkinson were in court. Bunting is out of town. Kirkland is in

Michigan. Judge O'Connor, as junior member of the court, read his judgment first. He took up the main question of whether the bribery of a member or members of the

legislature, or an attempt to bribe him o them, was an indictable offence, and h held that it was not. A case which he held to be analagous to the present one was that of Wasen, who was charged with having told a falsebild in giving evi dence to a committee of the British house of commons, which sat as a judicial tribu-nal. The petition on which he was charged was not admitted by the house of lords, and he afterwards charged the committee with makin injurious statements against him, which they know are not true; in other words I charged them with conspiring to injurchim. The court of queen's bench laid down as a principle that parhament should deal with such cases itself, and that the only instruces in which members could be charged before the courts for their action n the house were for treason, felony and breach of the peace. That law, he held, obtained to the present day. He contended that this was a proper view to take of the case, because members of parlia ment were not like public officers of any other kind, inasmuch as they were respon tible to their constituents for their co duct, and should be dealt with by the people themselves or the people's represen-tatives. He quoted other authorities in sup port of this position. He referred to what he termed a common practice of bribery in the form of treating members to wine, etc., in order to induce them to support meas ares in which the men who treated then were specially interested. He also obbying measures resorted to in the United States and elsewhere promises which were made in order to carry mes through parliament. These ca I dealt with at all, were dealt with by parliament itself, and charges of bribery we enever heard of in the courts in con

sequence of such actions. In the case of his loss, John Kirwin, once a member of the Expelled for accepting a bribe of £1000 In this case no criminal proceedings had been taken against Sir John. In such a case parliament long ago assumed and possessed the exclusive right to dea English house of commons, he had bee such cases, and such a course applie with full force to the present case. This case should be disposed of by the legisla-ture. In the Wasen case, before referred o, there had been no interference by the sourts. In the case of Wasen there had o charge as to treason, felony or a of the place, therefore it was held that it was a use to be dealt with by the house of parliament. There was no mate rial difference between the two cases. In concluding, Mr. O'Connor said the question was whether this was a crimina offence in this and one that could be deal with by the courts of law as such. He had concluded that the demurrer should be allowed, and that the indiction to quas the indictment ought to prevail. Judge Armour said he thought it was beyond doubt that the matter was a misde canor and an offence amenable to the criminal courts. In support of this con tention he quoted several cases in th United States courts. He did not think the motion to quash the indictment should prevail. In his opinion judgment should be given to quash the demurrer and judg ment given for the crown. Chief Justice Wilson prefaced his decisure to draw sion by stating that it should be under stood that they only had to deal with the legal point of the case. They had nothing to do with its merits. The charge against the defoundants the defendants was not a charge of briber but an attempt to bribe or conspiracy t bribe. It was a conspiracy to g members of the legislature to acce ge money to do an improper act, it was bribery or an attempt to bribe it would be a common offence. As parlia ment had power to punish for offence, such right was independent of th power of the courts in the matter. Con spiracy to bribe was undoubtedly a com mon law offence. An attempt to bribe member of parliament was undoubtedly common law offence. The legislative as sembly was a criminal court in all case where there was a breach of the privilege: of The house. The speaker of the house might issue a warrant for the arrest of ; member of parliament, to bring him up for a contumacious hearing. Such a perso who was being arrested might resist the officer and kill him. Was that member t he tried by parliament for the crime ho had committed there while a member of the Kouse?" One member might shoot another in the house of commons for using in sulting or unparliamentary language to wards him, and it did not follow that the tegislature should deal with such an effence. The chief justice quoted the On tes, bearing on the case in ques ion, and said that the legislature migh equiro into the offence without prejudi to the trial of such case by the wants of haw. It was equally clear that the legis ative assembly had no jurisdiction in such a case which this court had. It might be said that if the defendants were proceeded against by the legislature, and that if the lemurrer- was not sustained, they were table to punishment twice for the same ffince. 


