

To May 31, 1946, 9,989 claims have been appraised in an amount of \$4,729,600, or an average of \$473.48 per claim. It is estimated that an additional 1,731 claims in an amount of \$545,400 remain to be paid.

To May 31, 1946, 323 claims have been rejected for the following reasons: Duplications, 226; no damage, 31; consequential loss, personal injuries and government property, 66.

It is estimated that 555 claims presently under review will be rejected because (a) not owner of property, and (b) no reasons given for not having filed claim prior to cut-off date of January 31, 1946.
