deal with the matter as was the case when nthe Wolfe monument was toppled on the plains of Abraham?

Mr. Chevrier: I believe the situation to be about the same, except when the municipal and the provincial authorities ask the R.C.M.P. to step in. In such a case the circumstances are different, but I do not know what is the situation about the F.L.Q.

I believe the mounted police offered their services to the provincial and municipal police forces.

AGRICULTURE

DAIRY PRODUCTS—INQUIRY AS TO CALLING OF CONFERENCE

On the orders of the day:

Mr. W. B. Nesbitt (Oxford): Mr. Speaker, I should like to direct a question to the Minister of Agriculture. Has the minister as yet had an opportunity to continue discussions with his colleagues the ministers of agriculture in Ontario and Quebec with respect to the various problems affecting the dairy industry, and also of discussing these matters with the heads of the dairy organizations? If he has not had an opportunity to do so, does he intend to arrange in the immediate future such a conference as that which has taken place in the past?

Hon. Harry W. Hays (Minister of Agriculture): Mr. Speaker, before we dealt with the present policy, which has been widely publicized, I called in the dairy council and also the dairy farmers of Canada from coast to coast, and we discussed the policy with them. We had only two or three days to take care of this policy because, as you know, on May 1 it would have become effective on 80 per cent of the 10 year average if we had not done something in a hurry. This matter should have been taken care of long ago. Nevertheless we had to come up with something fairly quickly in order to protect the dairy farmers and the dairy industry of Canada, and this is the program which has been publicized. We were careful to seek the advice of all people interested in the dairy industry before we announced the policy which is now in effect.
