The first brief on the first bill we dealt with was sent to us by the Quebec Association Hospital Medical Boards. All the members received it and I am sure all of them have read it. That brief gives the point of view of the doctors. It enumerates the reasons which forbid them to accept the principle of abortion, or the bill, as it is from the human and medical points of view.

We have also been made aware of the grievances of the religious authorities through the declaration of the Canadian Catholic Bishops on abortion. Catholics know where they stand.

We also received from the Alliance for Life a release on the reasons for which they oppose the bill.

At the start, as in the case of homosexuality, we tried to pull out from the omnibus bill those two articles so that they could be voted on separately. We failed all down the line. Again tonight my words fall upon deaf ears. My words run off like water on the backs of ducks. The public will know that I speak on deaf ears, because members have been given strict orders, and when the leader has spoken, they must comply. I want to move, Mr.-
