RECOMMENDATION THAT STANDING COMMITTEE ACT AS NATIONAL PROTECTIVE BODY ON SAFETY

Mr. Barry Mather (Surrey): Mr. Speaker, I had a question for the Minister of Transport but in his absence perhaps his Parliamentary Secretary could answer it. AGRICULTURE

DAIRYING—AMOUNT OF SUBSIDY ON MANU-FACTURING MILK

Mr. R. E. McKinley (Huron): Mr. Speaker, I have a question for the Parliamentary Secretary, in the absence of the Minister of Agriculture, seeking further clarification of the dairy policy for the coming year as announced on Monday by the minister. The minister announced that the subsidy on manufactured milk will be maintained at the same level as this year, namely \$1.25 per hundredweight. Does this mean that \$125 million will be available if needed, which is the same amount as last year, rather than \$10 million less, as was announced some time ago?

Mr. Florian Côté (Parliamentary Secretary to Minister of Agriculture): It is very difficult to know, Mr. Speaker, what the requirements of the Canadian Dairy Commission will be as the farmers associations are negotiating an agreement between themselves at the present time with a view to bringing all producers of industrial as well as fluid milk to contribute to the setting of marketing rates or marketing prices. Once these plans have been submitted to the government, we will be in a better position to know what marketing will cost.

Mr. Roch La Salle (Joliette): I wish to ask a supplementary question, Mr. Speaker.

Mr. Speaker: The hon. member for Joliette has the floor.

Inquiries of the Ministry

Mr. La Salle: Mr. Speaker, I should like to ask the Parliamentary Secretary to the Minister of Agriculture if he can tell the House quite clearly, in the interest of the dairy producers, whether or not the \$10 million subsidy will still be granted. I think it is important that this question be answered in the House, Mr. Speaker.

Mr. Côté (Richelieu): Mr. Speaker, I can only give the same answer. The announcement made by the Minister of Agriculture was based on one of the recommendations made by the Standing Committee on Agriculture. The hon. member for Joliette and my colleague who asked a question a moment ago, moved in the Committee on Agriculture that the price be maintained at \$1.25.
