The electoral districts of Quebec, Montmorency, and the greater part of Portneuf are within the boundaries of the Quebec City CMC.

STATUS OF HOLDERS OF PASSPORTS ISSUED BY REGIMES NOT RECOGNIZED BY CANADA

# Question No. 515-Mr. MacLean:

Are visitors, in some cases, refused entry to Canada simply because they are travelling on passports issued by certain coun-

tries and, if so, what are the countries whose citizens are not allowed entry to Canada?

Hon. Bryce Mackasey (Minister of Manpower and Immigration): A passport issued by a regime not recognized by the Government of Canada is not considered as a valid passport for purposes of the Immigration Act. Because of this, a person who seeks entry as a visitor and presents only such a passport is refused. Examples of such passports are those issued by the regimes of East Germany, North Korea, North Viet Nam and Taiwan. If, however, such a person is in possession of some other form of travel document which is acceptable to the Canadian Government he is allowed entry. In addition, citizens of Southern Rhodesia are prohibited from entering Canada, except on humanitarian grounds. Details of this can be found in the reply to question No. 419 given by the Secretary of State for External Affairs on January 11, 1971, as recorded on page 2255 of Hansard.
