(a) and (b) The Hon. Mr. Justice Alfred M. Monnin, a member of the Court of Appeal of Manitoba, Chairman. The Hon. Mr. Justice Jacques Boucher of the Superior Court of Quebec, Member. The Hon. Mr. Justice Samuel S. Bard of the Superior Court of Quebec, Member. His Honour Judge M. L. Tyrwhitt-Drake of the County Court of the County of Victoria, British Columbia, Member. - 1. Is Statistics Canada having its researcher's data returned (a) by post (b) by bank messenger service (c) by other means?
- 2. If any means other than the post is being used, for what reason?
- Mr. Herb Breau (Parliamentary Secretary to Minister of Industry, Trade and Commerce): Statistics Canada reports that: 1. (a) The bulk of Statistics Canada's survey questionnaires (researchers' data) are returned via post. (b) Bank Messenger Service is used occasionally. (c) Rail Express is used for bulk shipments.
- 2. The Bank Messenger Service is used occasionally when it is necessary to meet survey deadlines. Rail Express is used for economical reasons, to transport bulk shipments of survey questionnaires to and from the eight regional offices across Canada. Other means such as telex, telegrams, or telephone may occasionally be used to confirm or obtain additional data, etc.

NATIONAL HEALTH AND WELFARE—RETURN OF PLASTIC MILK CONTAINERS

Question No. 621-Mr. McKenzie:

Does the government consider returnable three-quart plastic containers for milk as a health hazard and, if so, does it intend to enact legislation which would prevent dairies from distributing them?

Hon. Marc Lalonde (Minister of National Health and Welfare): No. When used as intended, these bottles are not considered to constitute a hazard to health. The primary concern regarding the returnable plastic containers for milk results from consumer misuse of these bottles as storage containers for gasoline, solvents and other obnoxious materials.
