Hon. David MacDonald (Secretary of State and Minister of Communications): Mr. Speaker, the question is an important one. We have engaged in a rather wide-ranging process of consultation in order to ensure that, not only in the case of the new chairman to be appointed but in the case of the other two members to be appointed, we will have outstanding people to provide service to a rather important institution in regard to telecommunications policy for this country.

ENVIRONMENTAL STUDIES BEFORE EMBARKING UPON POSSIBLE HARMFUL PROJECTS

Mr. Lorne Nystrom (Yorkton-Melville): Mr. Speaker, my question is directed to the congenial Minister of the Environment. It concerns two extremely important projects at either end of the country, namely, the proposed flooding of 12,000 acres of farmland by B.C. Hydro, and the proposal for putting a highway through the heart of the Annapolis Valley in Nova Scotia which will destroy some of the best farmland in that province.

Will the minister promise full-scale environmental impact studies before either of these projects goes ahead, and will he recommend to cabinet the possibility of cutting off fundings for Highway 101 in Nova Scotia unless an alternative route is found which will not destroy good farmland?

Hon. John A. Fraser (Postmaster General and Minister of the Environment): Mr. Speaker, with respect to the question of the flooding of land in the event that a dam is built in British Columbia, that is a matter which is, of course, fundamentally the responsibility of the province of British Columbia. I will be discussing the entire situation shortly with the new minister of [Mr. Clark.]

the environment in the province of British Columbia. I was to meet with him on Friday of this week. Unfortunately, I will not be able to attend, so that meeting will be rescheduled.

On the question of farmland and the highway, I will be discussing that matter with my officials and my colleagues and will be able to give the hon. member a more satisfactory answer at a later time.

Mr. Nystrom: A supplementary question, Mr. Speaker. In May of last year, the former minister of the environment said that a federal land use policy would be announced shortly thereafter. I should like to ask the minister when we can expect that announcement, in view of the fact that we are losing thousands of acres of prime farmland every year. According to the government, we are not now capable of feeding our people in almost every foodstuff area except grain. When can we expect that important study?

Mr. Fraser: Mr. Speaker, the studies have been completed and the cabinet document on federal land use policy is being prepared and will be delivered to cabinet shortly. I must point out to the hon. member and other hon. members that the federal government does not have jurisdiction over any land in the country that comes within provincial jurisdiction or which is alienated into private ownership. As a consequence, the actual power of the federal government to control land use in the country is understandably limited.
