REQUEST TO END PROMOTION OF VIOLENCE

What is interesting to see in this petition sponsored by Christiane and Gérald Gatien is how they succeeded in identifying incentives to violence such as violent movies shown on television, a problem aggravated by videos, electronic games where players try to kill animated characters such as animals and people, deadly gun licences as demonstrated recently at the École polytechnique in Montreal, and freedom of the press. If, on the same day, we hear a great speech on Canadian unity and we see someone trampling on the Quebec flag, we can be sure that tonight most media reports will focus on the latter.

So all this publicity, this incitement to violence attracted the attention of my fellow citizens, and I am honoured to table this petition on their behalf.

PEARSON INTERNATIONAL AIRPORT
