ought to be considered by hon. members and ought to be remedied.

In the meantime with this particular case and keeping in mind the matter raised by the hon. member and the fact that clearly there is here a breach of the rules and the sensitivities of the hon. members and the sensibilities of the hon. member's petitioners, I think the appropriate thing at least for today is to ask the parliamentary secretary to address the House tomorrow and see if there is some explanation at least. That may not fully satisfy the hon. member or hon. members, but at least for today that is where I would like to leave it.

HOCKEY CANADA-SPEAKER'S RULING

Mr. Speaker: On Monday, February 1, 1993 the House leader of the Official Opposition rose on a question of privilege regarding a question asked during Question Period on Friday, December 11, 1992. As this was the last Question Period before the House rose for its Christmas recess the hon. member for Cape Breton—East Richmond has raised this matter at the first opportunity. I would like to thank him and the Solicitor General for their interventions on this matter.

In his presentation on Monday last, the House leader of the Official Opposition noted that on December 11, 1992 he had put a question to the Minister of State for Fitness and Amateur Sport asking the government to provide the complete financial statements for Hockey Canada since its incorporation. The then Minister of Justice, responding on behalf of her colleague the Solicitor General, stated:

-this matter is currently being investigated by the RCMP. The Government of Canada will offer no further information until the RCMP has concluded its investigation.

Subsequently, on December 17, 1992, Mr. Ian Macdonald, chairman of the board of Hockey Canada, issued a press release stating that the financial records of Hockey Canada were not under investigation by the RCMP. It was from this discrepancy of fact that the question of privilege was raised by the hon. member for Cape Breton—East Richmond.

The situation was cleared up when the Solicitor General, in response to the question of privilege, indicated that it was National Hockey League Players' Association that was being investigated by the RCMP, and not Hockey Canada, which is fully co-operating with the RCMP in this investigation. In the Solicitor General's absence, the hon. Minister of Justice had taken the matter under advisement, to deal with the situation, which was not fully understood at the time. As the Solicitor General has now been able to clear up the situation, it is obvious that there was no attack on the House and that this is not a case of contempt of Parliament.
