## Oral Questions

## **INDIAN AFFAIRS**

### ALLEGATION OF DIVERSION OF FUNDS BY MANITOBA INDIAN BROTHERHOOD—GOVERNMENT ACTION

**Mr. Ray Hnatyshyn (Saskatoon-Biggar):** Mr. Speaker, I would like to direct a question to the Minister of Indian Affairs and Northern Development. I gave him notice of this question last week. Is the minister in a position today to report on the allegations made by Mr. Tony Walker, formerly employed by the Manitoba Indian Brotherhood, regarding certain irregularities relating to possible diversion of government funds given to the Manitoba Indian Brotherhood for research?

Hon. Warren Allmand (Minister of Indian Affairs and Northern Development): Mr. Speaker, officials in my department have been investigating this matter for about nine months now. They started the investigation long before the allegations were recently made. We see nothing of the nature of what was described by the person concerned, but there were some problems with financing, and we are working those out.

**Mr. Hnatyshyn:** Mr. Speaker, my information is that when Mr. Walker brought this to the attention of the assistant deputy minister, the department then referred the matter back to the Manitoba Indian Brotherhood. I wonder if the minister can explain why his department asked the brotherhood to investigate itself on this particular matter, and further, whether the minister is prepared to appoint an independent auditor to verify expenditures made by the brotherhood, as stipulated in the memorandum of agreement between the government and the brotherhood, especially in light of the fact that Mr. Tony Walker was fired from the brotherhood immediately after bringing this to the attention of the assistant deputy minister.

**Mr. Allmand:** Mr. Speaker, that is not correct. The matter was being investigated by officials of the department, including some from Ottawa, and not by the Manitoba Indian Brotherhood. However, the financial problems are being worked out between the officials of my department and the MIB. As I said earlier, the matters in question were not brought to light by Mr. Walker. They were known for some time. As a matter of fact, I met with the executive of the MIB several times long before Mr. Walker made his statement.

**Mr. Hnatyshyn:** Mr. Speaker, there is an agreement between the MIB and the department which provides for the appointment of an independent auditor to look into the affairs of the MIB relating to government funds. Will the minister now undertake to have an independent auditor investigate the records with respect to expenditures and with respect to the allegations raised by Mr. Walker?

**Mr. Allmand:** Mr. Speaker, if that has not already been done, I will look into that possibility.

### SYDNEY STEEL—REQUEST FOR AID IN MODERNIZING PLANT— GOVERNMENT POSITION
