

Bill, intituled, "An Act to authorize the Corporation of the Township of *St. Vincent*, in the County of *Grey*, to construct a Harbour at the mouth of *Bighead* River; in the said Township, to impose and collect harbour dues, and for other purposes."

Bill, intituled, "An Act to authorize the *Wyoming* Petroleum Company, to hold and convey certain lands."

Bill, intituled, "An Act to provide for the sale of the Rectory Lands in this Province."

Bill, intituled, "An Act to amend the provisions of several Acts relating to the City of *Montreal*, and for other purposes."

Bill, intituled, "An Act to amend the Acts incorporating 'The College of *Ottawa*,' and to grant certain privileges to the said College."

Bill, intituled, "An Act to legalize and confirm an Agreement made between the Grand Trunk Railway Company of *Canada* and the *Buffalo* and *Lake Huron* Railway Company."

Bill, intituled, "An Act to amend the charter of the British and Canadian School Society of *Montreal*."

Bill, intituled, "An Act to authorize the *New York* and *Canada* Oil Company to hold and convey certain lands."

Bill, intituled, "An Act to authorize the sale of the *Peterborough* and *Chemong* Lake Railway, and for other purposes."

Bill, intituled, "An Act to erect a new municipality in the County of *Beauharnois* under the name of *St. Etienne de Beauharnois*."

Bill, intituled, "An Act to authorize the *Hartford* Oil Company to hold and convey certain lands."

Bill, intituled, "An Act to legalize a certain By-law and certain Debentures of the United Counties of *Huron* and *Bruce*."

Bill, intituled, "An Act to incorporate the Town of *Bothwell*; and to define the limits thereof."

Bill, intituled, "An Act to confirm and make valid the Will of the late *George Desbarats*, in *Upper Canada*."

And also, the Legislative Council have passed the following Bills, with amendments, to which they desire the concurrence of this House:—

Bill, intituled, "An Act to incorporate the Ecclesiastical Society of *St. John*, in the Roman Catholic Diocese of *Kingston*."

Bill, intituled, "An Act to amend the Act incorporating the *Quebec* Marine Insurance Company."

Bill, intituled, "An Act to authorize the issuing of Letters Patent of Invention to *Arthur Rankin* for a new and hitherto unknown description of fuel."

And also, the Legislative Council have passed the following Bills of their own; to which they desire the concurrence of this House:—

Bill, intituled, "An Act to postpone, for a limited time, the issuing of writs for the next election of Members of the Legislative Council."

Bill, intituled, "An Act to amend the Medical Act for *Upper Canada*."

Bill, intituled, "An Act to amend the Act incorporating the *Belleville* Seminary and to confer on the same University powers, in so far as regards Degrees in Arts."

And then he withdrew.
