Hon. Richard A. Bell (Minister of Citizenship and Immigration): Mr. Speaker, a thorough revision of the Indian Act based upon the report of the select committee of the Senate and the House of Commons is under active drafting. The complexity and importance of the act are such that I am advised it will likely be early in the new year before the drafting can be completed. At that stage the bill would be introduced for first reading, not with the intention of proceeding at this session of parliament but at a subsequent session. In the interim it would be my intention to meet on a provincial basis with representatives of the Indians in every province to discuss the important provisions which are proposed.
