May I draw your attention to the fact that there is nothing wrong with the hearing of the Minister of National Health and Welfare who is capable, I think, of speaking for himself. If he was here when the vote was called he would have been the first to rise in his own defence. The minister found it necessary to leave his seat and he probably got caught on the way.
