Have studies been made concerning a second proposed site for the Mauricie National Park and, if so (a) what was the nature of the studies (b) when were they carried out and by whom (c) what reasons did the Government of Quebec give for not selecting that site.

Hon. Jean Chrétien (Minister of Indian Affairs and Northern Development): (a) A combination of office and aerial field studies were carried out to review and corroborate existing publications and available data. (b) Initial studies were carried out in June 1968 and were followed by more detailed studies during the period July 1968 through February 1970. These studies were carried out by the National and Historic Parks Branch. (c) As in the case of all parks, surveys are made in broad areas to find the location offering the greatest potential, before the present area was designated.

TELEVISION—CANADIAN INSTITUTE OF PUBLIC OPINION POLL

Question No. 282-Mrs. MacInnis:

Is the Department of Consumer and Corporate Affairs aware of the recent opinion poll by the Canadian Institute of Public Opinion in which 69 per cent of Canadians feel that television commercials use untruthful statements and, if so, what action is contemplated by the Department?
