#### EFFECT OF U.S. IMPORT SURTAX—STATUS OF CONSULTATIONS WITH UNITED STATES

Considering the 10 per cent surtax on imports entering the United States, has he any new indications that Canada will be protected against this measure?

**Right Hon. P. E. Trudeau (Prime Minister):** No, Mr. Speaker, and that is why the government proposed a special measure to the House. Indeed, in the next few days we shall probably ask the House to pass the bill on third reading.

In light of the fact that Cornwall is already suffering under a 20 per cent unemployment rate, is the government going to take any action? In view of the announced delay until we deal with other matters, has he any intention to take specific action to avert further lay-offs at Courtaulds Limited as a result of the loss of business with the United States and because of the very specific situation there? Would he also indicate to the House and to the people of Cornwall whether or not the employment support bill can be expanded or whether or not there is any action under that which the Prime Minister might pursue to ensure against these proposed lay-offs?

**Right Hon. P. E. Trudeau (Prime Minister):** It is my understanding that the bill still before the House is one which will be applicable in all parts of Canada, and I am hopeful that the people of Cornwall and the industries in Cornwall will be able to obtain help under it.

#### POSSIBILITY OF SURTAX ON IMPORTS FROM JAPAN

**Hon. Marcel Lambert (Edmonton West):** My question is for the Minister of Finance. Would he say whether he or the Secretary of State for External Affairs or any of their officers indicated to the Japanese ambassador or any of his officials during the recent meeting in Toronto that unless Japan or other countries drastically reduce their exports to Canada, Canada would consider imposing a surcharge?

**Hon. E. J. Benson (Minister of Finance):** No, Mr. Speaker, but one of the things we have brought to the attention of the Japanese is that we certainly did not want to be subject to receiving goods which are diverted because of the surtax in the United States.

**Mr. Lambert (Edmonton West):** Is the government of Canada considering a surcharge or any other measure which would effectively control the import into Canada of goods from countries such as Japan?

**Mr. Benson:** No, Mr. Speaker.
