Mr. Wenman: —why have you not presented this to the House? When will you do so, who is stopping you from presenting this to the House?

Some hon. Members: Order.

Mr. Speaker: Order, please. In addition to reminding the hon. member that his question is argumentative, I might point out I have refrained from reminding hon. members of the fact that all questions and remarks in this chamber are traditionally put to the Chair and not directly to the person who is being questioned. I refrained from doing that at the beginning of the session in order to allow hon. members time to acquaint themselves with the procedures, but it might be well now to remind hon. members of that.

Mr. Wenman: Through you, Mr. Speaker, may I ask the minister to answer my question.
