## HOUSING

ASSISTANCE TO HOME OWNERS TO MEET INCREASED MORTGAGE PAYMENTS

Right Hon. Joe Clark (Leader of the Opposition): Madam Speaker, my question is directed to the Minister of Finance. It has to do with the high cost of housing and interest rates. I put it to the Minister of Finance that he is prepared to have his government pay \$1.5 billion for an oil company but is not prepared to come to the aid of Canadians who are facing high interest rate charges and who are faced with the prospect of not being able to renew their mortgages.

The minister will recall that in the throne speech the government promised, and I quote:
