**Mr. J. P. Nowlan (Annapolis Valley-Hants):** Madam Speaker, my question is directed to the Minister of Public Works. In view of all the speculation about the future of Cartier Square—from zoos, to galleries, to concrete canyons and skyscrapers—would the minister tell the House if the public will have an input long before the NCC makes any final decisions on the future of this very vital section of real estate right in the heart of the capital district?

**Hon. Paul J. Cosgrove (Minister of Public Works):** Madam Speaker, I am happy to confirm to the hon. member that the public has already had quite an opportunity for input. The committee of Cartier Square interest groups has made representations to me directly as minister, to the chairman of the National Capital Commission, to the city, to the local school board and to local school officials. Many people have had input into the design and consideration for the use of the square up to this point.

official documents of the Quebec government prove beyond a doubt that only such contractors as have their head offices in Quebec can tender for projects financed jointly and often mostly by the federal Department of Regional Economic Expansion, while the province of New Brunswick opens its doors to all comers for such projects, can the right hon. Prime Minister tell us how, with regard to the freedom of movement of persons, goods and services it will be possible to put an end to that type of balkanizing discrimination through the constitutional reform?

**Hon. Pierre De Bané (Minister of Regional Economic Expansion):** Madam Speaker, I must say to the hon. member that he has raised an extremely important question indeed. All provinces are in the process, directly or otherwise, of putting up non-tariff barriers. Naturally, a province cannot expect to benefit simultaneously from free access to the whole Canadian market when it suits it, and when the prosperity of its industries depends on the rest of the Canadian market, while in other cases denying to other provinces free access to its own market. That problem is fundamental and I am very happy that the right hon. Prime Minister has made a priority of it in the constitutional review.

I wonder whether the minister could advise the House if I can expect to receive that full list today?
