## VALLEY RIVER INDIAN BAND—PURCHASE OF GRAVEL PIT

**Mr. Laverne Lewycky (Dauphin-Swan River):** Mr. Speaker, the Valley River Indian Band in my constituency has been after the Department of Indian Affairs to assist in the purchase of a ballast pit within their reserve. This pit could be compared to the hole in a doughnut relative to its location in the reserve. An offer to sell the land to the Band was made in 1981, but no meaningful action was undertaken by the Department. The sum of \$15,000 was asked for but not accepted. This represents a pittance when one takes into account the fact that the Department spent \$30,000 over the last two years to supply gravel to this reserve.

This historically legitimate land claim should have been settled years ago, had the Minister heeded my representations. The social and economic value of this land to the Band is far greater than the amount requested. I call upon the Minister and the Department to act immediately to secure this piece of land for the Valley River Indian Band under their land claims programs and projects.

## ALLEGED STATEMENT BY GOVERNOR

**Mr. Jean-Claude Malépart (Parliamentary Secretary to Minister of Public Works):** Mr. Speaker, I rise under the provisions of S.O. 21 to protest against a statement by the Governor of the Bank of Canada, Mr. Bouey, who said yesterday that workers are partially responsible for high interest rates in this country, because they are getting higher wage increases than their American counterparts.

Mr. Speaker, I think Mr. Bouey is being unfair to Canadian workers. He should not forget that last year, most workers in Canada took cuts in wages, and others were obliged, as in Quebec by the provincial Government, to forgo scheduled wage increases. Furthermore, most workers have had to accept the work sharing concept.

Mr. Speaker, I think Mr. Bouey ought to set an example and take a cut in salary or simply offer his resignation.
