3. *Resolved*, That a sum not exceeding Eight thousand one hundred dollars be granted to Her Majesty, to defray the following expenses in connection with Public Buildings: *Montreal* Examining Warehouses, \$2,500; *Montreal* Custom House, repairs and furniture, \$5,600, for the year ending 30th June, 1882.

4. *Resolved*, That a sum not exceeding Four thousand three hundred and fifty dollars be granted to Her Majesty, to defray the following expenses in connection with Public Buildings, *Ontario*: *Ontario* Cattle Quarantine Stations, additional amount
