## LEVIS QUARANTINE STATION.

#### Mr. DOHERTY:

- 1. The Government is aware that Ferdinand Lemieux and Arthur Morency claim servitude upon the property purchased by the Government for a quarantine station at Lévis.

The legal advisers of the Government are of the opinion that the claim of Mr. Ferdinand Lemieux is not well founded, and an action has been instituted by the said Ferdinand Lemieux and is now standing for hearing in the Exchequer Court to determine the validity of his claim. The servitude claimed by Arthur Morency consists in the alleged right to maintain a water pipe passing through part of the property from a spring on the hill to his As the presence of this dwelling house. pipe upon the property does not at present interfere with the work of the station no steps have been taken to have it removed.
