# ST. LAWRENCE SEAWAY AUTHORITY—BOARD OF DIRECTORS

### Question No. 67-Mr. Argue:

1. Are there any vacancies on the board of directors of the St. Lawrence seaway authority? 2. If so, how many, what positions, how long has each been vacant?

3. Who are the present members and what are their duties?

Hon. Leon Balcer (Minister of Transport): Mr. Speaker, in reply to part 1, the answer is yes.

In reply to part 2, there is one vacancy, that of member, which position has been vacant since March 31, 1959.

In reply to part 3, the present members of the St. Lawrence seaway authority are R. J. Rankin, president, and Dr. Pierre Camu, member. Their duties are as follows. The president shall be the chief executive officer of the authority and shall preside at all meetings of the authority; he shall have the general and active direction and control of the business of the authority and of the general conduct of the affairs of the authority; he shall see that all orders and resolutions of the authority are carried into effect; he shall have general superintendence and direction of all other officers of the authority and shall see that their duties are properly performed.

During the incapacity or absence for any reason of the president, or vacancy in the office of the president, one of the other members designated by the governor in council may exercise and perform all the powers and functions of the president. Dr. Camu was so designated by P.C. 1960-1281 of September 20, 1960.
