SUGGESTED WITHDRAWAL OF BILL

Mr. G. W. Baldwin (Peace River): Mr. Speaker, I would like to ask the Prime Minister whether, in view of the

universal opposition, he will now agree to withdraw Bill C-190?

Right Hon. P. E. Trudeau (Prime Minister): I do not know if the hon. member is seriously suggesting this, Mr. Speaker. As the House knows, the bill was drawn up by the government following the directions given to it by the committee chaired by a Conservative member and of which, I understand, the member asking the question was also a member. If it is the desire of the House to withdraw this bill, we will certainly give it most serious consideration, but it seems to me the opposition is in the curious position of reproaching the government for drawing a bill which follows exactly the instructions given to it by the committee.

Mr. Baldwin: Is the Prime Minister not aware that this party, irrespective of the views of the committee, was, is and still will be totally opposed to the principles of this bill? I would also like to ask the Prime Minister—

Mr. Speaker: Order, please.

Mr. Baldwin: I would also like to ask the Prime Minister—

Mr. Speaker: Order, please.

Mr. Baldwin: -if he will agree-

Mr. Speaker: Order. The hon, member knows the reservations which the Chair has about asking questions about a bill on the order paper, discussion of which has not yet been reached. That is clearly anticipating a government order. I allowed the hon, member to ask the question because I felt guilty about having disallowed his questions so often, but I suggest we should not enter into a debate at this point.

Mr. Trudeau: On a question of privilege, Mr. Speaker—

Mr. Baldwin: On the point of order-

Mr. Speaker: Order. The Prime Minister rises on a question of privilege. I believe a question of privilege has precedence over the hon. member's point of order.

Mr. Trudeau: Mr. Speaker, the hon. member put on the record that the government knows that the opposition are opposed to this bill. I do not know how we could know—

Mr. MacInnis: That is not privilege.

Mr. Horner: That is no point of privilege.

Mr. Trudeau: The privilege is that we are told we know something—

Mr. Diefenbaker: That's a mistake.

Mr. Trudeau: —and I say we cannot possibly know it.
