PRIVATE AIRCRAFT USER CHARGES  
AND FEES

Motion No. 282—**Mr. Skoberg:**

That an Order of the House do issue for a copy of the review on user charges and fees paid by private aircraft using the facilities provided by the Department of Transport as mentioned by the Minister without Portfolio in *Hansard* of November 26, 1969 on page 1291.

**Mr. Gérard Duquet (Parliamentary Secretary to Minister of Transport):** Mr. Speaker, it is a continuing study which is not yet completed. The Department of Transport is presently considering the whole matter of charges, including those that are paid for various types of private aircraft.

When a decision is reached in that regard, the government will examine the possibility of giving the requested information to the House.

Until then, I would ask the hon. member to withdraw his motion.

DEFENCE PRODUCTION SHARING—U.S. FIRMS  
EXPORTING TO CANADA

Motion No. 288—**Mr. Broadbent:**

That an Order of the House do issue for a list of all United States firms exporting to Canada, products under the Canada-U.S. Defence Production Sharing Agreement from its inception in 1959 to November 30, 1969, listing the specific materials and components coming into Canada and the dollar aggregates involved.

**Mr. J. A. Jerome (Parliamentary Secretary to President of the Privy Council):** Mr. Speaker, the Minister of Industry, Trade and Commerce wishes to inform the hon. member that to compile a list of purchases by the Canadian government would be costly and, at best, would constitute only a partial reply since information on private companies' purchases is held to be commercially confidential. He is able, however, to table estimates of the dollar aggregates involved if this is acceptable to the hon. member.

**Mr. Broadbent:** It is acceptable.

**Mr. Speaker:** The motion is carried subject to the reservations and conditions expressed by the Parliamentary Secretary.

Motion agreed to.

MOVEMENT OF OIL FROM ALBERTA TO QUEBEC

Motion No. 307—**Mr. Douglas (Nanaimo-Cowichan-The Islands):**

That an Order of the House do issue for copies of all studies, reports, memoranda, etc., regarding the statement made in Parliament by the Minister of Energy, Mines and Resources and reported in *Hansard* of December 11, 1969 on page 1851 that: "if oil were sent from Alberta to Quebec in the east, it would be very costly. Indeed, pipelines would have to be built from Western Canada, which would not be profitable".

**Mr. J. A. Jerome (Parliamentary Secretary to President of the Privy Council):** Mr. Speaker, with reference to the hon. member's motion I have to say that there are no specific studies, reports, memoranda, etc. regarding the statement to which he refers. I would point out, however, that it was remarked before the Standing Committee on National Resources and Public Works on May 8 last year that the price of Alberta crude brought as far west as Toronto was some 60 cents a barrel above the laid-down price—
