Inquiries of the Ministry

PROPOSED JAMES BAY HYDROELECTRIC PROJECT—DATE OF PUBLICATION OF ENVIRONMENTAL STUDY

Mr. Lloyd R. Crouse (South Shore): Mr. Speaker, I wish to direct a question to the right hon. Prime Minister. In view of the fact that some 1,300 men are now working on the James Bay project and contracts are being issued monthly, will the Prime Minister inform the House when the environmental study on the impact of this project, which affects Quebec, Ontario and Manitoba, will be made public?

RELATIONSHIP OF LOSS OF JOBS IN ONTARIO TO INCENTIVE GRANTS

Mr. Arnold Peters (Timiskaming): Mr. Speaker, I wish to direct a question to the Minister of Regional Economic Expansion. In view of the report issued by the Ontario government that in 1971 36 companies shut down or curtailed operations in Ontario costing 4,341 workers their jobs, would the minister inform the House whether his department has made any studies which would establish whether or not those lost jobs in Ontario were directly or indirectly linked to industrial incentive grants given to industries in designated regions?
