## PUBLIC BUILDINGS

Mr. Dinsdale: Does the minister intend to accept the advice of the hon. member for Cochrane, who has advised the government either to get rid of them or to place a shroud over them, or is he going to wait until the Canadian people place a shroud over the government?

## CAPE BRETON DEVELOPMENT CORPORATION

DENIAL BY CORPORATION OF CANADA PENSION PLAN BENEFITS TO MINERS—GOVERNMENT ACTION TO RECTIFY

Mr. Donald MacInnis (Cape Breton-East Richmond): Mr. Speaker, I have a question for the Minister of Regional Economic Expansion. While expressing appreciation of the fact that he has corrected Tom Kent's wrongful approach to Canada Pension Plan benefits, will the minister carry this action one step further and ensure that Cape Breton miners on retirement will have returned to them the Canada Pension Plan benefits wrongfully taken from them by Mr. Kent?

Hon. Donald C. Jamieson (Minister of Regional Economic Expansion): Mr. Speaker, while I cannot, of course, accept the premise of the question since this matter is a legal one interpreted by the courts, a decision having been made I have indicated to the hon. member and the House, following discussions with the Minister of Justice, that if there is some avenue through which this question can be raised to determine the appropriateness of the hon. member's representations I am quite prepared to consider this. The Minister of Justice has indicated that he, too, will be looking into the matter.
