2. Of those Indian students attending high school from 1969 to 1972, how many were enrolled in the two-year course and how many in the four-year course?

1. How many immigrants from Portugal were processed (a) in the Immigration Office in Lisbon during 1972 (b) in Canada on applying in Canada as landed immigrants for landed immigrant status when in Canada in 1972, 1971 and 1970?

2. What is the time delay between an immigrant indicating that he would like to apply to come to Canada at the Lisbon Office and the time when he is eventually interviewed by an interview officer in the office?

3. In the event that the time delay is in excess of six weeks, is the Minister of Manpower and Immigration proposing to significantly increase the immigration officer staff in Portugal?

4. Is it the Minister's view that immigrants from Portugal integrate well into Canada?
