PRIVATIZATION OF FOREST PRODUCTS LABORATORIES

Mr. F. Oberle (Prince George-Peace River): Mr. Speaker, I would like to address my question to the Minister of State (Environment). In light of the uncertainty he has created with regard to the future of the forestry service as a result of recent policy changes, changes which are resulting in a mass exodus of scientists and diligent public servants to other industries and other parts of the world, has the minister received iron-clad assurances from the private sector that his privatization scheme is, in fact, working? If not, is he prepared to defer previous decisions to close down the forests products labs and some of the research stations for the reason of lack of money?

Hon. Len Marchand (Minister of State (Environment)): Mr. Speaker, I will be making an appropriate announcement very soon. I want to assure the hon. member that our plans for privatization are going fairly well. I also want to tell him that he should be more careful in his choice of words, because not one of the research labs is being closed down. We have six research labs across the country. In terms of the privatization of those two forest products labs, the hon. member should not use the words "closing down". As a result of the planning now going on, and looking at privatization, we hope that once we have completed all the negotiations, those two labs will remain intact and, indeed, their position will be enhanced as a result of working with provincial governments, the private sector and the universities. Their service to the forest industry will, therefore, be enhanced.

Mr. Oberle: I am encouraged by the minister's remarks. I interpret him to mean that the research labs will not be closed down even if his privatization plan does not proceed. I interpret his remarks to mean that his decision to phase out—the federal government's decision—by April 1 is being deferred. Can the minister communicate that comfort to the people who are leaving the department as a result of his decision? Can he, also, make reference to the institutions that are being closed in Ottawa, the Forest Management Institute and the Forest Fire Institute?

Mr. Marchand: Mr. Speaker, there is no change in moving the Forest Management Research Institute to Petawawa: That is going ahead. The Forest Fire Research Institute's move to Petawawa is going ahead.

I have said on previous occasions in this House that we feel, as a result of the amalgamation of the Forest Fire Research Institute and the Forest Management Research Institute in Petawawa, that that facility will become one of the foremost research institutions for forestry in the country. I should also tell the hon. member that we think very highly of the Canadian Forestry Service. It has done an excellent job. I ask the hon. member to just wait for a little while until he hears the announcements we will be making.
