2. The balance sheet of the Canadian Northern Railway system as presented is a consolidated balance sheet as required by statute 1914 embracing all of the affiliated companies, so that this statement shows all the liabilities outstanding both of the parent company and the affiliated companies.

3. Particulars are shown on page 10 of the blue-book No. 237.

4. All loans to the Canadian Northern railway are shown in the blue-book No. 237. When the loans are repaid all securities held will revert to the Canadian Northern railway.

Hon. Mr. BOSTOCK: Nothing is said about the loans to Mackenzie and Mann, Limited. The inquiry is made in paragraph 4.

Hon. Sir JAMES LOUGHEED: If my honourable friend thinks that he can get any further information of a more specific character, I shall be glad to do it.

Before the Orders of the Day:

Hon. Mr. LANDRY: At the outset I should like to congratulate our new acquisition to this House. I regret that his commission has not been read in French. I thought he was a French Canadian, but now I am not sure.

Hon. Sir JAMES LOUGHEED: We will look into that.

Hon. Mr. CLORAN: Hear, hear. The point is well taken.

Hon. Mr. LANDRY: I want to call the attention of the House to an incident that took place yesterday, and which is not reported as it should be, or if it was reported as it should be we were under a misapprehension yesterday. On page 935 and 936 the report says:

The Hon, the Speaker: I shall have to name the honourable gentleman the next time.

L'honourable M. Choquette: Monsieur l'Orateur, considérant votre position et comment vous l'avez reçu, vous ne devriez pas faire tant de zèle pour le gourvernement.

The Hon. the Speaker: Asseyez-vous. Sit down. The honourable gentleman has no right

to be insulting.

Hon. Sir James Lougheed: I ask the honourable the Speaker to maintain order, and if the honourable gentleman does not maintain order, I ask the Speaker to name him.

So the honourable the leader of the House was under the impression at that time that the Speaker had not named the

honourable member for Grandville, and if we look at the report we find nothing at all previous to that time to show that he had been named. Then the report goes on to say:

The Hen. the Speaker: I have named him. Hon. Sir James Lougheed: Then I propose to move a motion.

Hon. Mr. Domville: What is the meaning of

Some Hon. Senators: Order.

Then Sir James Lougheed said:

Inasmuch as the honourable the Speaker has named the honourable gentleman from Grandville (Hon. Mr. Choquette), if that honourable gentleman does not refract his discourtesy to this House, I will move that he be suspended from the service of the House for a certain number of days. I propose doing that at once.

Then a remark which I made is attributed to Hon. Mr. Belcourt. I said:

Before the honourable gentleman from Grandville answers, I want to state that His Honour the Speaker did not name the honourable member. He told him "Asseyez-vous"—sit down. That is not the way in which the Speaker names a member.

The Hon. the Speaker: I beg pardon; I named the honourable gentleman, and asked

him to sit down.

So, after looking at the report, I am still convinced that the honourable the Speaker did not name the Hon. Mr. Choquette.

Some Hon. SENATORS: Hear, hear.

Some Hon. SENATORS: Order.

Hon. Mr. LANDRY: What is the point of order?

Hon. Mr. CLORAN: They do not know.

Hon. Mr. DANIEL: The honourable the Speaker says that he did name the honourable gentleman.

Hon. Mr. LANDRY: I say that I am still convinced that he did not name him, and shouting, "Order, order" or anything else will not change that conviction.

Hon. Mr. DANIEL: I rise to a point of order, Mr. Speaker. Under our regulations it is the duty of every member to accept the statement of any member made in this House. The Speaker has stated that he did name the Hon. Mr. Choquette, and it is out of order for any member of this House to question that statement. I would like a ruling on that point.

Hon. Mr. LANDRY: I suppose that I can answer the honourable gentleman. I have that right. I did not say that the Speaker did not name Hon. Mr. Choquette. I said that I was still under the conviction that he did not. If he says he did, I sup-
