altered certificate, knowing the same to be forged, counterfeited, interlined, erased or altered, or shall knowingly and wilfully utter and publish any such Certificate with intent to obtain the effect of a true Certificate to be given thereto, knowing the contents of such Certificate to be false, he or she shall be guilty of Felony.

XXI.-And be it further enacted, that if any person shall land or unship, or shall move in order to the landing or unshipping thereof, any Goods, Wares or Merchandize, Packets, Packages, Baggage, Wearing Apparel, Books, Letters, or other Articles, from on board any Vessel liable to perform Quarantine as aforesaid, or shall knowingly receive the same after they have been so landed or unshipped. every such person shall forfeit and pay the sum of Three Hundred Pounds Sterling money as aforesaid; and if any person or persons shall Persons clandes. clandestinely convey or secrete or conceal for the purpose of conveying any Letters, Goods, Wares and Merchandize, or other Articles as Vessels under Quarantine subaforesaid from any Vessel actually performing Quarantine or from the ject to a penalty Lazaretto or other place where such Goods, Wares and Merchandize of £100. or other Articles as aforesaid shall be performing Quarantine every such person so offending as last aforesaid shall forfeit the sum of One Hundred Pounds Sterling money as aforesaid.
