> Herewith are presented the first portraits yet published of two of the best known and most widely popular members of the Victoria contingent belonging to Strath-cona's Horse, which sailed yesterday on the steamship Monterey from Halifax for South Africa.

CAPT. T. E. POOLEY. The accompanying portrait of Lieut. T. E. Pooley, of Strathcona's Horse, is an excellent picture of a typical British Columbia boy. Nearly six feet in height and built in proportion, with grit stamped in every lineament of his features. "Tom," as he is known among his friends, is a splendid representative of the loyal city which bears the name of the beloved British Queen. He is a na-tive son, and was born 24 years ago; but he spent eight years of his early life in England, being educated mainly at Bradfield college. Pooley became one of the most enthus-iastic and active members of the Fifth Regiment. 


