

He also laid before the House,—Copies of Orders in Council passed under the provisions of the Unemployment and Farm Relief Act, 1931, and Continuance Act, 1932, the Relief Act, 1934, the Relief Act, 1935, as follows:—

Order in Council, P.C. 277, dated February 4, 1936: authorizing payment to the province of Quebec of the sum of \$520.20 for municipal direct relief, provincial direct relief in organized municipalities, provincial direct relief in unorganized territories.

Order in Council, P.C. 278, dated February 4, 1936: authorizing payment to the province of Saskatchewan of the sum of \$5,005.44 for relief settlement.

Order in Council, P.C. 279, dated February 4, 1936: authorizing payment to the province of Manitoba of the sum of \$2,214.74 for relief settlement.

Order in Council, P.C. 280, dated February 4, 1936: authorizing payment to the province of Alberta of the sum of \$1,157.54 for movement of necessary feed and fodder and equipment into the dried out areas; movement of settlers and their effects and stock from dried out areas.

Order in Council, P.C. 2137, dated July 24, 1935: authorizing payment of the sum of \$21.69 to the province of Alberta for municipal direct relief.

Order in Council, P.C. 2252, dated August 1, 1935: authorizing payment to the province of Quebec of the sum of \$7,061.86 for municipal direct relief in organized municipalities and provincial direct relief in unorganized territories.

Order in Council, P.C. 2343, dated August 7, 1935: authorizing payment to the province of Quebec of the sum of \$3,108.73 for provincial direct relief in unorganized territories and municipal works in the city of Verdun.

Order in Council, P.C. 2597, dated August 23, 1935: authorizing payment to the province of Quebec of the sum of \$3,532.16 for municipal works at St. David d'Estcourt, Temiscouata County.

Order in Council, P.C. 3070, dated October 4, 1935: authorizing payment to the province of Quebec of the sum of \$2,093.12 for municipal direct relief in organized municipalities and provincial direct relief in unorganized territories.

Order in Council, P.C. 3835, dated December 17, 1935: authorizing payment to the province of Alberta of the sum of \$3.79 for municipal direct relief in M. D. Champlain, No. 544; and authorizing payment to the province of British Columbia of the sum of \$60.60 for provincial direct relief in Yale Electoral District.

Order in Council, P.C. 276, dated February 4, 1936: authorizing payment to the province of Quebec of the sum of \$28.78 for municipal direct relief in organized municipalities and provincial direct relief in unorganized territories.

Order in Council, P.C. 320, dated February 10, 1936: appointing Kenneth Marsh to the staff of the Unemployment Relief Branch of the Department of Labour, as a clerk at a salary of \$90 per month.

Order in Council, P.C. 325, dated February 10, 1936: authorizing payment to the province of Ontario of the sum of \$18 for relief.

Order in Council, P.C. 326, dated February 10, 1936: authorizing payment to the province of Ontario of the sum of \$39 for direct relief.

Order in Council, P.C. 327, dated February 10, 1936: authorizing payment to the province of Quebec of the sum of \$7,551 for expenditures made in the city of Montreal by the Emergency Unemployment Relief Committee in respect to federal tax on tobacco, which was donated by the manufacturers to single homeless men on relief, from December 1, 1932, to March 30, 1934.

Order in Council, P.C. 281, dated February 6, 1936: appointing Mr. Henry Laframboise as an investigator to the staff of the Unemployment Relief Branch of the Department of Labour at a salary of \$135 per month to fill the vacancy caused by the death of Patrick Green.
