

Order in Council P.C. 3061, dated October 11, 1939: authorizing printing and distribution of copies of Orders in Council passed under the provisions of the War Measures Act.

Order in Council P.C. 3065, dated October 11, 1939: extending time, etc., with regard to Mining Rights of holders enlisting with British or Allied Forces.

Order in Council P.C. 3093, dated October 12, 1939: granting pardon, under certain circumstances, to deserters from permanent forces, on re-enlisting.

Order in Council P.C. 3105, dated October 12, 1939: authorizing purchase of railway equipment for the Canadian National Railway and the Canadian Pacific Railway.

Order in Council P.C. 3108, dated October 12, 1939: empowering convenor of the sub-Committee of Council on Public Information to designate a member of the Public Service of Canada for the purpose of signing requisitions for stationery supplies, etc., for the said sub-Committee.

Order in Council P.C. 3109, dated October 12, 1939: amending Defence Purchasing Board Regulations respecting a quorum, etc.

Order in Council P.C. 3114, dated October 12, 1939: respecting Civil Servants' Insurance—War endorsement *re* enlisted Civil Servants.

Order in Council P.C. 3115, dated October 12, 1939: authorizing living expenses of \$15 per diem to Walter S. Thompson, as Director of Censorship.

Order in Council P.C. 3116, dated October 12, 1939: appointing Henry Brown, Esquire, of Toronto, as Technical Advisor to the Wool Administrator, with actual travelling and living expenses.

Order in Council P.C. 3117, dated October 18, 1939: appointing James McGregor Stewart, Esquire, K.C., of Halifax, N.S., as Coal Administrator, with living allowance of \$20 per diem.

Order in Council P.C. 3118, dated October 19, 1939: seconding Frank G. Neate, Esquire, of Ottawa, Secretary of the Dominion Fuel Board to serve as Technical Advisor to the Coal Administrator.

Order in Council P.C. 3119, dated October 12, 1939: regulating discharge to pension of Naval Officers and ratings.

Order in Council P.C. 3120, dated October 21, 1939: authorizing the supervision and direction of the Central Investigation Committee of the Department of National Defence by the War Supply Board.

Order in Council P.C. 3121, dated October 19, 1939: transferring control, temporarily to the War Supply Board, of the employees of the Contracts Branch of the Department of National Defence, at their current rates of compensation.

Order in Council P.C. 3122, dated October 12, 1939: authorizing increase in strength of the Royal Canadian Air Force.

Order in Council P.C. 3124, dated October 12, 1939: regulating manufacture and export of fertilizers.

Order in Council P.C. 3136, dated October 18, 1939: protecting mining rights under Yukon Quartz and Placer Mining Acts of holders enlisting with British or Allied Forces.

Order in Council P.C. 3139, dated October 18, 1939: amending Defence of Canada Regulations—penalties for offences.
