NATIONAL PARKS**BONNE BAY, NFLD.—OIL EXPLORATION RIGHTS—REQUEST FOR PUBLIC HEARING**

Mr. Jack Marshall (Humber-St. George's-St. Barbe): I have a question for the Minister of Indian Affairs and Northern Development. In view of the complications which have arisen with regard to the establishment of a national park in the province of Newfoundland and the evidence of oil exploration rights, would the minister agree to hold a public hearing in the province similar to that held in Nova Scotia to ascertain the legality of such rights which are seriously hindering economic development?

Hon. Jean Chrétien (Minister of Indian Affairs and Northern Development): Mr. Speaker, there is no need to hold a public hearing to determine whether there can be oil prospection in a park. It is a well-known policy in Canada that no prospection of any kind whatsoever can be carried out in a park. If the government of Newfoundland wants to be given a second national park, it will have to abide by the federal legislation on national parks, just as do the other provinces.
