I should like simply to ask the minister, since there will be unemployment in Yarmouth, whether he is studying the problem in order to reduce to a minimum the number of employees who will be laid off.

# CANADA ASSISTANCE PLAN

REFUSAL OF BENEFITS TO MEMBERS OF B.C. BUILDING TRADE UNIONS

Mrs. Grace MacInnis (Vancouver-Kingsway): Mr. Speaker, I have a question for the Minister of National Health and Welfare which arises from a situation in British Columbia where the locked-out members of seven building trade unions have been refused welfare payments, contrary to the terms of the Canada Assistance Plan. In view of the television refusal of welfare minister Gaglardi to comply with the federal minister's request that the terms of the plan be met, can the minister say what action he plans to take to enforce the terms of the legislation?

Hon. John C. Munro (Minister of National Health and Welfare): Mr. Speaker, I indicated the provisions of the Canada Assistance Plan to the minister to whom the hon. member has referred, and also that any such obstacle placed in the path of recipients in terms of receiving benefits would be contrary to the plan. All I can say is that if we have specific instances where recipients are denied benefits contrary to the plan we will have no choice but to take appropriate action in terms of reducing the moneys payable to that province under the Canada Assistance Plan.

## Inquiries of the Ministry

Mrs. MacInnis: Mr. Speaker, I have a supplementary question. In view of the fact the provincial government got its own way, which was not in accord with the terms of the plan, in connection with the people involved in the longshoremen's strike, is there any guarantee that things will be different this time?

**Mr. Speaker:** Order, please. I doubt whether the supplementary is in order. I would not think that the question, in the terms it was asked, would be acceptable.
