PETITION PROTESTING CONSTRUCTION OF U.S. NUCLEAR  
BASE NEAR VANCOUVER, B.C.

**Mr. Stuart Leggatt (New Westminster)**: Mr. Speaker, I have the honour this afternoon to present a petition to the House representing one signed by some 10,500 Canadian citizens, protesting the construction of the Trident nuclear base some 60 miles south of the city of Vancouver. In essence, the petition seeks action from this House to protest the lack of consultation by the United States in respect of the construction of the base, and also to protest the dangerous escalation of the arms race this base represents in having a first-strike capacity. Further, it follows the decision of the city of Vancouver to declare November 23-29 as Trident Concern Week in that area.

**Mr. Baker (Grenville-Carleton)**: I rise on a point of order, Mr. Speaker. In view of the importance of the letters the Minister of Transport (Mr. Lang) has just tabled, I wonder if the government House leader would agree that these be printed today as an appendix to today's *Hansard*, because of the importance of this matter.

**Mr. Speaker**: Order, please. There has been a request that the documents tabled by the Minister of Transport (Mr. Lang) be printed as part of *Hansard*. Is there agreement?

**Some hon. Members**: Agreed.

**Some hon. Members**: No.

**Mr. Speaker**: This can only be done with the unanimous consent of the House. There is not unanimous consent.
