That Bill C-14, an act to amend the Unemployment Insurance Act, 1971, be amended in clause 5 by striking out lines 9 to 14 at page 4 and substituting the following therefor:

"24. (1) The rate of weekly benefit payable to a claimant for a week of unemployment that falls in his/her benefit period

(a) in the case of a claimant without a dependant is an amount equal to fifty per cent of his/her average weekly insurable earnings in his/her qualifying weeks,

(b) in the case of a claimant with a dependant is an amount equal to sixty-six and two-thirds per cent of his/her average weekly insurable earnings in his/her qualifying weeks,

(c) for the purposes of paragraph (b) where a husband or wife or a common-law husband or a common-law wife qualifies as a claimant with a dependant, either the husband or wife or either the common-law husband or common-law wife may elect to qualify as a claimant with a dependant, and

(d) notwithstanding anything in paragraphs (b) and (c), in the case of a claimant who lost his/her employment by reason of his/her own misconduct or who voluntary left his/her employment without just cause is an amount equal to fifty per cent of his/her average weekly insurable earnings in his/her qualifying weeks."
